5. Constitution and deeds update

- We can include digital methods of holding meetings and making decisions but need to include that in the new constitution
- Every committee member can have a vote under foundation model
- You can have a minimum of three committee members to be quorate for voting
- VH network has ACRE model constitution that is a starter for ten
- There are no legal requirements we need to meet (e.g. minimum numbers of committee or quotes that have to be included)
- We have to make a constitution that suits the community and then abide by that
- The final document has to be submitted to the charity commission
- We need to vote and minute that the new document has been accepted



- Charity Commission will review it and if it's not accepted they will come back with clarifying questions and/ or advice to amend it so that's it's suitable
- Whatever is then held by CC is what the management committee will be held to
- Dissolution clause: best to keep it flexible and say it will be distributed to another local charity in South Shropshire with similar objectives, voted on by the committee.
- We can continue to use the old constitution for things like 100 Club until new one is finalised
- Funds will need to be audited this year because we're over the limit to need to be audited
